DEFINITIONS

KCN Business: means any partnership, corporation, joint venture or other legal entity legally and beneficially owned or controlled by one or more of the Keeyask Cree Nations or one or more Members that meet the criteria to be considered a Northern Aboriginal Contractor.

Keeyask Cree Nation (KCN): means any one of Tataskweyak Cree Nation, War Lake First Nation, York Factory First Nation, and Fox Lake Cree Nation.

Member: means a person who is, in respect of a Keeyask Cree Nation, a "member of a band" as defined in subsection 2(1) of the Indian Act (Canada).
[Subsection 2(1) of the Indian Act (Canada) - member of a band: member of a band means a person whose name appears on a Band List or who is entitled to have his name appear on a Band List.]

Northern Aboriginal Contractor - a Manitoba business (including Aboriginal Joint Venture, partnership or corporation):

- that is at least 50 per cent owned by an Aboriginal resident(s) or organization(s); AND
- that is based in or whose Aboriginal owner has resided within the Northern Affairs boundary for a cumulative period of five (5) years or more.

Manitoba Hydro reserves the right to request further documentation from the proposed registrant demonstrating it meets the definition of a KCN business and placement in the directory will be conditional upon receiving such information.
