## RE: Manitoba Hydro 2015/16 & 2016/17 General Rate Application – Round I Information Requests

On March 12 and 18, 2015, Manitoba Hydro filed responses to a substantial number of Round I Information Requests from the Public Utilities Board of Manitoba ("PUB"), the Consumers' Association of Canada and Winnipeg Harvest ("COALITION"), the Manitoba Industrial Power Users Group ("MIPUG"), the Green Action Centre ("GAC"), Manitoba Metis Federation ("MMF"), Manitoba Keewatinowi Okimakanak ("MKO") and the combined requests of COALITION and MKO.

Enclosed please find additional responses to Round I Information Requests which have been completed at this time. Manitoba Hydro is also including a revised response to Coalition/MH I-84b which was filed on March 12, 2015. Manitoba Hydro is continuing its review and completion of the few outstanding IRs, including those identified by the PUB in Order 33/15, on a best efforts basis and anticipates filing those responses early next week.
