- Please ensure you provide all applicable information in the 'Notes for Inspector' section so enough time is booked for the inspection.
- Please allow 2 business days to schedule your inspection after we receive this form.
- Inspection times are 9 a.m. to 3 p.m. weekdays (excluding weekends and statutory holidays).
- Inspections booked through your ePermit account can be confirmed faster and you will receive a notification when inspections are confirmed.
